Although 2020–2021 was certainly the most challenging school year most of us can remember, it was also a year of tremendous growth for the Foundation for Portland Public Schools (FPPS). During this past year, FPPS doubled our revenue that benefits Portland Public School (PPS) students. Several of our existing initiatives, like the Families in Crisis Fund and PPS Food Fund, grew exponentially in response to increased needs of PPS families during the pandemic. In our efforts to be responsive to the changing needs

of our schools, we also launched several new programs this year, including Addressing the Opportunity Gap, the PPS Coronavirus Relief Fund, Outdoor Teaching and Learning, and several managed funds.

Another exciting development was becoming the fiscal sponsor for Portland Empowered, an organization that raises the voices of traditionally underrepresented stakeholders to improve our schools. We believe their work complements our efforts and furthers our mission.

We have diversified our board leadership and built capacity by adding students from Casco Bay, Deering, and Portland High Schools as full, voting members of our Board of Directors. We also launched our first Advisory Board this year with a tremendous group of community leaders and thinkers.

We do this work because schools are the center of our community. Research shows that students do better when families and local community organizations are engaged in schools. We'd like to thank all of the family members, business and community partners, and philanthropic supporters who have supported our work. We welcome your involvement as volunteers, thought partners, advocates, and donors.

In the 2020–2021 school year, FPPS worked with district leaders, educators, students, and families to identify and fundraise for a range of priority areas that benefit schools and students.

Addressing the Opportunity Gap deepens and accelerates systemic racial equity work in the district

### **Equity and Innovation Teacher Grants**

enable teachers and other staff to invest in innovations they believe will have meaningful impact and reach for students

**Families in Crisis Fund** helps vulnerable PPS families with emergency needs other than food such as housing, utilities, transportation, medical costs, or critical supplies

**PPS Coronavirus Response** allows flexibility in responding to unanticipated needs and expenses that arise from the pandemic including increased communications, health and safety outreach, and supplies to distribute to families

**PPS Food Fund** addresses food insecurity for students and their families

**STEM Funds** support additional opportunities for students in the areas of science, technology, engineering, and math

## **FPPS MANAGED FUNDS**

FPPS is pleased to work with a variety of individuals and organizations to create and manage funds in the interest of schools and students.

Annetta Weatherhead Fund at Reiche School provides flexible and easily-accessible financial resources to improve the lives of Reiche students and enhance

**Barbara Anderson Scholarships** recognize first generation college students at Portland High School who demonstrate strong academic achievement and financial need

**Make It Happen! Scholarships** provide four years of financial support for immigrant or refugee students who have been accepted to college

**Rising Tide Awards** provide summer opportunities for students from immigrant families to pursue academic and personal interests, strengthen college applications, and develop leadership skills

**SolaRise** funds construction of solar arrays on school buildings through advocacy and collaboration between students, the City of Portland, environmental groups, and funders

**Step Up Awards** allow recipients at Portland High School to participate in extracurricular opportunities by decreasing the need to work after school and/or on weekends

**Thompson Scholarships** honor two Brown Medal Scholars and two poets graduating from Portland High School each year

## 2020-2021 EQUITY AND INNOVATION TEACHER GRANTS

The FPPS Equity and Innovation Grants Program supports teacher-led class-room innovations which enhance learning experiences for PPS students. The program recognizes, rewards, and supports teachers' work to inspire students and improve learning outcomes in alignment with the Portland Promise.

In 2020-2021 FPPS awarded 61 grants totaling \$48,595 impacting 6,348 student experiences

They reduce barriers and create opportunities for emerging youth and adult leaders so that youth in Portland Public Schools are successful in school and beyond. We all want Portland students to be fully prepared to participate and succeed in a diverse and ever-changing world. But we have inherited educational policies and practices that systematically afford advantages to some groups while perpetuating inequities for others.

The Addressing the Opportunity Gap Fund was created in response to friends and neighbors looking for local ways to support efforts to root out systemic or ongoing inequities and to become actively involved in anti-racist work. The fund allows us to continue and accelerate the work PPS is already deeply engaged in around curriculum, professional development, policy, and hiring.

In year one, we raised over \$98,000. The John T. Gorman Foundation, Martin's Point Community Health, and Unum led the way in supporting our efforts. And we are already having an impact.

- Students and families are connecting deeply with the multilingual/ multicultural social work interns that were supported and mentored with these funds.
- Thousands of students will see themselves reflected in culturally reflective picture books and textbooks purchased this spring.
- The number of highly qualified, new staff of color is slowly growing, and research shows clearly that this increases graduation rates and overall achievement for students.

We all need to do our part so that our future leaders have the skills they need to tackle the problems of tomorrow. Local employers confirm that they prioritize employees who are comfortable with diverse perspectives and can work through differences. We need broad community support for this work to change our collective culture. The Addressing the Opportunity Gap Fund is part of the solution.
